A. Lessor shall furnish all labor, materials, tools, equipment, services, and associated work to complete the attached scope of work in the amount of \$11,626.50. Alterations shall be coordinated with the on-going tenant improvement allowance and this change shall not affect the expected completion date. Upon completion, inspection, and acceptance of the alterations by the Government, a lump sum payment in the amount of \$11,626.50 will be made after the lessor properly submits the invoice and required documents stated in paragraph B below.
