This Supplemental Lease Agreement (SLA) No. 7 has been prepared to issue acceptance and Notice to Proceed (NTP) of the Lessor's proposals, indicated in the attached 3pages to this SLA, in the amount of \$7,048.30, for the signage in the office space at 3614 3<sup>rd</sup> Street West, Manatee County, Bradenton FL 34205-8926. The IGE(s) have been received and the cost has been determined to be fair and reasonable.

The Lessor will be issued a lump sum payment in the amount of \$7,048.30 upon completion, inspection and acceptance of the Scope of Work by the Government. Except as modified in this Agreement, all terms and conditions of the Lease shall remain in full force and effect, and in the event that any of the terms and conditions of the Agreement conflict with any terms and conditions of the Lease or any previous supplemental lease agreements, the terms and conditions of this Agreement shall control and govern.


