THIS AGREEMENT, made and entered into this date by and between **Dahl Brothers Bradenton ICE, LLC**

whose address is: **2515 W. Watrous Avenue

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the **Government**:
WHEREAS, the parties hereto agree to supplement the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective **June 6, 2011** as follows:

This Supplemental Lease Agreement (SLA) No. 3 has been prepared to issue acceptance and Notice to Proceed (NTP) of the Lessor's proposals, indicated in Exhibit "A" and "B" attached to this SLA, in the amount of **\$1,191,399.89**, for the space build-out at 3614 3rd Street West, Manatee County, Bradenton FL 34205-8926. The IGE(s) have been received and the cost has been determined to be fair and reasonable. **\$857,902.71** will be paid in a lump sum as stated below, and **\$333,497.18** shall be amortized in the rent per paragraph (9) of the SF2.

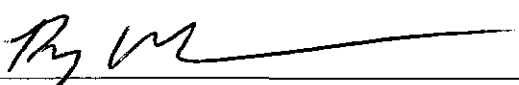
Payment will be due only for items which are listed in the Scope of Work, Exhibit "A" and "B" attached to this SLA or requested in writing by the Contracting Officer. With the following exceptions; the Generator and [REDACTED] will be omitted. The [REDACTED] will be omitted and replaced with an [REDACTED].

The Lessor will be issued a lump sum payment in the amount of **\$857,902.71** upon completion, inspection and acceptance of the Scope of Work by the Government. Payment is predicated on receipt of this signed SLA and a certified invoice at the time of work completion. All invoices shall be sent to: U.S. General Services Administration, Finance Division – 7BCP, 819 Taylor Street, Fort Worth, Texas 76102-0181, or www.finance.gsa.gov.

Except as modified in this Agreement, all terms and conditions of the Lease shall remain in full force and effect, and in the event that any of the terms and conditions of the Agreement conflict with any terms and conditions of the Lease or any previous supplemental lease agreements, the terms and conditions of this Agreement shall control and govern.
