






THIS AGREEMENT, made and entered into this date by and between <div style="display: flex; justify-content: space-between;"> <div style="width: 40%;"> whose address is </div> <div style="width: 55%;"> Joliet SSA LLC 694 Grandview Lane Lake Forest, IL 60045 </div> </div> <p>hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:</p> <p>WHEREAS, the parties hereto desire to amend the above Lease.</p> <p>NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective <u>May 17, 2011</u>, as follows:</p> <p>Supplemental Lease Agreement (SLA) Number 3 is issued to establish termination rights accordingly to the actual effective date.</p> <p>1. SF2 Paragraph 4 of the lease is deleted in its entirety and replaced with the following SF2 Paragraph 4:</p> <p>" 4. The Government may terminate this lease on May 16, 2021 or at anytime after May 16, 2021 by giving a 90 day notice of cancellation. No rental shall accrue after the effective date of termination.
