- 1.) The Government accepts the leased space on September 15, 2011.
- 2.) The commencement date of the rental shall be September 15, 2011 and shall expire on September 14, 2021.
- 3.) The office space square footage shall be 3,232 rentable square feet yielding 3,232 ANSIBOMA Office Area (ABOA).
- 4.) The Government shall pay the Lessor annual rent as follows:

From September 15, 2011 through September 14, 2016 the total annual rent shall be \$46,624.00 at the rate of \$3,885.33 paid monthly in arrears. The total annual rent consists of Shell Rent of \$29,800.00 and Operating Costs of \$16,824.00 plus annual Operating Cost adjustments. There are no annual Tenant Improvement costs.

From September 15, 2016 through September 14, 2021 the total annual rent shall be \$49,249.00 at the rate of \$4,104.08 paid monthly in arrears. The total annual rent consists of Shell Rent of \$32,425.00 and Operating Costs of \$16,824.00 plus annual Operating Cost adjustments. There are no annual Tenant Improvement costs.
- 5.) The percentage of occupancy for Tax Reimbursement purposes shall be: 100% (3,232 Rentable Square Footage, (RSF) /3,232 RSF) and the new Base Year for taxes shall be the taxes in the year of 2011.
- 6.) The Government's adjustment of vacant space shall be a reduction of \$3.00/RSF .
- 7.) All other terms and conditions of the lease shall remain in full force and effect.
