**WHEREAS**, the parties hereto desire to amend the above Lease to: **issue the Notice to Proceed to install security equipment in the temporary swing space, Suites 305, 400 and 1325**

**NOW THEREFORE**, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective 09/11/2018 as follows:

- A. The Government hereby accepts the Lessor's proposal for alterations to the Premises as agreed by all parties and in accordance with the Lease terms, the Lessor's proposal, and the scope of work provided. The price to the Government for the alteration totals the NOT TO EXCEED amount of \$17,190.96. Work done above the specified amount will be the Lessor's sole responsibility.
- B. The Lessor shall furnish all labor, materials, equipment, design, professional fees, permit fees, inspection fees, utilities, construction cost and services, and all other similar cost and expenses associated with the alterations to the space as stated in the Statement of Work. All work must be completed within 4 weeks from issuance of this Notice to Proceed.
- C. The Lessor will be paid a lump sum payment in the amount of \$17,190.96 after completion of the work and acceptance by the Government. Payment will only be due for items which are (a) stated in the Lease Amendment, (b) stated and depicted

- D. Lessor waives any restoration in connection with these items. Unless the Government has removed the item from the premises, Lessor shall remain responsible for maintenance, repair and replacement of all items provided by the Lessor under this lease. If after the lease term and any extended, renewal, or succeeding lease term the Government elects to abandon any items in place, title shall pass to the Lessor.

The Lessor is responsible for visiting this website and applying for a login name and password. After acceptance by the Government, the Lessor shall follow the instructions posted on the website to submit their invoice electronically.
