hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above lease to provide Notice to Proceed for approved Change Orders.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, March 5, 2015, as follows:

1. The Government hereby accepts the Lessor's Change Orders as listed in Exhibit A to provide, install, and maintain alterations to the above mentioned space as agreed by all parties in accordance with the lease terms, the scope of work provided and Lessor proposals dated as shown in Exhibit A.

Notice to Proceed (NTP) is issued totaling \$23,212.06 for all Change Orders as listed in Exhibit A. This shall include all necessary labor, approvals, materials, and equipment required to complete the alterations.

2. Upon completion, inspection, and the GSA's acceptance of the alterations, a properly executed invoice requesting lump sum payment in the amount of \$23,212.06 must be submitted electronically to GSA Finance and a copy of the invoice submitted to the Contracting Officer at:

3. Payment will only be made electronically through the finance website at www.finance.gsa.gov. The Lessor is responsible for visiting this website and applying for a login and password. After acceptance by the Government, the Lessor shall follow the instructions posted on the website to submit their invoice electronically. Assistance in navigating the website or submitting the invoice can be found by calling (817) 978-2408 or by email at FW-Paymentsearch.finance@gsa.gov.

For an invoice to be considered proper, it must:

- a. Be received after the acceptance of the work by the General Services Administration.
- b. Include an invoice date, a unique, vendor-supplied invoice number AND GSA supplied PS Number.
- c. Indicate the exact payment amount requested.
- d. Specify the payee's name and address.
- e. The payee's name and address must EXACTLY match the Lessor's name and address listed in the Lease contract.
- f. Include the Lease contract number, building address, and a description of the work provided, price, and quality of the item(s) delivered.

If the invoice is not submitted on company letterhead, the person(s) with whom the Lease contract is made must sign the invoice.



4. The Lessor hereby waives restoration as a result of improvement.
