WHEREAS, the parties hereto desire to amend the above Lease. Lease Amendment (LA) No.1 is issued to clarify paragraph 1.15, section A and B, and offer an alternative to previously agreed upon Lessor Shell alterations which address security deficiencies/concerns in the building.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective June 20, 2014 as follows:

A. In accordance with paragraph 1.15 "Building Improvements," sections A and B, Lessor has agreed to make necessary shell alterations as described in the Lease and in Lease Exhibit H in order to address the security deficiencies/concerns should the Lessor lease out the vacant space (Exhibit A - Space that is not included in this Lease contract) on the 1st floor to a new tenant (such as a non U.S. Government tenant). In exchange for said shell alterations as described in the Lease, the Government has agreed that Non Government tenants and their quests shall not be required to enter the building through the main entrance and be subjected to Government security screening. Alternatively, the Government agrees that should the Lessor be willing to comply with subjecting his Non-Government tenant and their guests to Government security screening, said alterations shall not be necessary, except to the extent where the Government secured parking area is concerned. Lessor shall still be responsible for ensuring that the current emergency egress door leading past the into the Government secured parking area is relocated, as to not allow unauthorized individuals access to Government secured parking area while still complying with local fire, life safety codes. See diagram as depicted on Exhibit H of the Lease.
