## 1.05 TERMINATION RIGHTS

The Government may terminate this Lease, in whole or in part, at any time effective after <u>March 31, 2017</u>, by providing not less than ninety (90) days' written notice to the Lessor. The effective date of the termination shall be the day following the expiration of the required notice period or the termination date set forth in the notice, whichever is later. No rental shall accrue after the effective date of termination.
