This Supplemental Lease Agreement (SLA) number 19 provides for design services and miscellaneous improvements to be made within the expansion space.


1. The Lessor agrees to provide, install and maintain carpet tile and base for the hallway area of the expansion. Additionally, the Lessor agrees to provide, design services for artwork to be installed in the same corridor. Work shall be in accordance with the attached proposal from Bill Seymore, Meritex V.P., dated October 5, 2005. Work must be completed within 30 days of the date of this Supplemental Lease Agreement.

Upon completion, inspection, and acceptance of the work by the Contracting Officer, and submission of a proper invoice, the Government agrees to compensate the Lessor in the amount of \$8,823.38 in a lump payment.
