WHEREAS, the parties hereto desire to amend the above lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended as follows:

This Supplemental Lease Agreement (SLA) Number 26 establishes the acceptance and occupancy date of 50,000 square feet warehouse and office space. Also contained in this SLA are the specific improvement and payment information contracted for the customization and build out of Office Area 2 and the AIRR.

1. Effective September 1, 2006, in accordance with Paragraph 3 of SLA 20 of the Lease, 5000 ANSI/BOMA Office Area square feet of office space (Office Area 2) is accepted by the Government.

As a result of this expansion, the Government agrees to pay the Lessor \$16,950.00 per annum (\$3.00 for shell and \$0.39 for operating). The new total annual rent is \$1,591,689.75. The Government now occupies a total of 469,525 USF/RSF.

2. Effective October 16, 2006, in accordance with Paragraph 3 of SLA 20 of the Lease, 45,000 ANSI/BOMA Office Area square feet of warehouse space (Stack Room 9) is accepted by the Government.

As a result of this expansion, the Government agrees to pay the Lessor \$152,550.00 per annum (\$3.00 for shell and \$0.39 for operating). The new total annual rent is \$1,744,239.75. The Government now occupies a total of 514,525 USF/RSF.

3. All rates herein exclude escalations to date, which are calculated annually as stated in the Miscellaneous Section, Paragraph 3.5.

All other terms and conditions of the lease shall remain in force and effect.
