Unless the Government has removed the item from the premises, Lessor shall remain responsible for maintenance, repair and replacement of all Items provided by the Lessor under this lease. If, after the lease term and any extended, renewal or succeeding lease term, the Government elects to abandon any items in place, title shall pass to the Lessor.
