The Lessor hereby leases to the Government the Premises described herein, being all or a portion of the Property located at

To Have and To Hold the said Premises with their appurtenances for the term beginning November 1, 2013 and continuing for a period of

subject to termination and renewal rights as may be hereinafter set forth, to be used for such purposes as determined by the General Services Administration. The commencement date of this lease, along with any applicable termination and renewal rights, shall more specifically be set forth in a Lease Amendment upon substantial completion and acceptance of the space by the government.

SECTION 1 THE PREMISES, RENT, AND OTHER TERMS

1.01 THE PREMISES

The Premises are described as follows:

Office and Related Space: 12,066 rentable square feet (RSF), yielding 11,164 ANSI/BOMA Office Area (ABOA) square feet of office and related space (based upon a Common Area Factor of 8.07%, located on the first floor(s) and known as Sulle(s) 100, of the Building, as depicted on the floor plan(s) attached hereto as Exhibit A.

1.02 EXPRESS APPURTENANT RIGHTS

The Government shall have the non-exclusive right to the use of Appurtament Areas, and shall have the right to post Government Rules and Regulations within such areas. The Government will coordinate with the Lessor to ensure signage is consistent with the Lessor's standards. Appurtament to the Premises and included with the Lesse are rights to use the following:

Parking: \$2 parking spaces as depicted on the plan attached hereto as Exhibit B of which zero shall be structured inside spaces reserved for the exclusive use of the Government, zero shall be inside parking spaces, and 52 shall be surface parking spaces. In addition, the Lessor shall provide such additional parking spaces as required by the applicable code of the local povernment entity having jurisdiction over the Property.

B. Antennae, Satellite Dishes and Related Transmission Devices: Space located on the roof of the Building sufficient in size for the installation and placement of the telecommunications equipment as such may be described herein, together with the right to access the roof and use of, all building areas (e.g., chases, plenums) necessary for the use, operation and maintenance of such equipment at all times during the term of this Lease.

1.03 RENT AND OTHER CONSIDERATION

A. The Government shall pay the Lessor annual rent payable monthly in arrears at the following rates from November 1, 2013 – October 31, 2023:

The Tenant Improvement Allowance is amortized at a rate of 4.24 percent per annum over 5 years.

- B. Rent is subject to adjustment based upon a physical mutual measurement of the Space upon acceptance, not to exceed \$1,164 ABOA sq. it based upon the methodology outlined under the "Payment" clause of GSA Form 3517.
- C. Rent is subject to adjustment based upon the final Tenant Improvement cost to be amortized in the rental rate, as agreed upon by the panies subsequent to the Lease Award Date.
- D. If the Government occupies the Premises for less than a full calendar month, then remishall be prorated based on the actual number of days of occupancy for that month.
- E. Rent shall be paid to the Lessor by electronic funds transfer in accordance with the provisions of the General Clauses. Rent shall be payable to the Payee designated in the Lessor's Central Contractor Registration.
- F. The Lessor shall provide to the Government, in exchange for the payment of rental and other specified consideration, the following:
 - The leasehold interest in the Property described in "Paragraph 1.01, The Premises" created herein.
- All costs, expenses and fees to perform the work required for acceptance of the Premises in accordance with this Lease, including all costs for labor, materials, and equipment, professional fees, contractor fees, attorney fees, permit fees, inspection fees, and similar such fees, and all related expenses.
 - 3. Performance or salisfaction of all other obligations set forth in this Lease, And

- 4. All services, utilities, and maintenance required for the proper operation of the Property, the Building, and the Premises in accordance with the terms of the Lease, including, but not limited to, all inspections, modifications, repairs, replacements, and improvements required to be made thereto to meet the requirements of this Lease.
- G. Parking shall be provided at a rate of szero per parking space per month (Structure), and szero per parking space per month (Surface).

1.04 BROKER COMMISSION AND COMMISSION CREDIT

Studiey, Inc ("Broker") is the authorized real estate broker representing GSA in connection with this lease transaction. The total amount of the Commission is the control of the commission is earlied upon lease execution, payable according to the Commission Agreement signed between the two parties. Only the payable to Studiey, Inc. with the remaining the commission of the Commission Credit", to be credited to the shell tental portion of the annual rental payments due and owing to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue until the credit has been fully recaptured in equal monthly installments over the shortest period practicable.

Notwithstanding the "Rent and Other Consideration" paragraph of this Lease, the shell rental payments due and owing under this lease shall be reduced to recapture fully this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue as indicated in this schedule for adjusted Monthly Rent:

1.05 TERMINATION RIGHT

The Government may terminate this Lease, to whole or in part, at any time effective after the firm ferm of this Lease by providing not leas than 90 days' prior written notice to the Leason. The effective date of the termination shall be the day following the expiration of the required notice period or the termination date set forth to the notice, whichever is later. No rental shall accrue after the effective date of termination.

1.09 TENANT IMPROVEMENT PRICING BASED ON TENANT IMPROVEMENT ALLOWANCE (JUL 2011)

The Tenant Improvement Allowance for purposes of this Lease is \$147,561.00 (\$13.22 PABOASF). The Tenant Improvement Allowance is the amount that the Lessor shall make available for the Government to be used for the Tenant Improvements. This amount has been amortized in the rent over the firm term of this Lease at an interest rate of 4.24 percent per year.

A. The Government, at its sole discretion, shall make all decisions as to the use of the Tj Allowance. The Government may use all or part of the Tenant Improvement Allowance. The Government may return to the Lessor any unused portion of the Tenant Improvement Allowance in exchange for a decrease in rent according to the agreed-upon amortization rate-over the firm term.

B. The Government shall have the right to make tump sum payments for any or all work covered by the Tenant Improvement Allowance. That part of the Tenant Improvement Allowance amorfized in the rent shall be reduced accordingly. At any time after occupancy and during the fam term of the Lease, the Government, at its sole discretion, may choose to pay tump sum for any part or all of the remaining unpaid amortized balance of the Tenant Improvement Allowance. If the Government elects to make a tump sum payment for the Tenant Improvement Allowance after occupancy, the payment of the Tenant Improvement Allowance by the Government will result in a decrease in the rent according to the amortization rate over the firm term of the Lease.

- C. If it is anticipated that the Government will spend more than the allowance identified above, the Government shall have the right to alther
 - Reduce the Tenant Improvement requirements.

 - Increase the rent according to the negotiated antortization rate over the firm term of the Lease.

1.12 PERCENTAGE OF OCCUPANCY FOR TAX ADJUSTMENT, ESTABLISHMENT OF TAX BASE

As of the Lease Award Date, the Government's Percentage of Occupancy, as defined in the Real Estate Tax Adjustment clause of this lease its 100%. The percentage of occupancy is derived by dividing the total Government space of 12,066 rentable square feet by the total building space of 12,066 rentable square feet.

1.13 OPERATING COST BASE

The parties agree that for the purpose of applying the clause titled "Operating Costs Adjustment" that the Lessor's base rate for operating costs shall be \$7.16 per rentable sq. ft.

1.14 RATE FOR ADJUSTMENT FOR VACANT LEASED PREMISES

In accordance with the section entitled "Adjustment for Vacant Premises" it the Government fails to occupy or vacates the entire or any portion of the Leased Premises prior to expiration of the term of the Lease, the operating costs paid by the Government as part of the rent shall be reduced by \$2.50 per ABOA sq. it. of space-vacated by the Government.

1.15 OVERTIME HVAC RATES

The following rates shall apply in the application of the clause littled "Overtime HVAC Usage:"

\$19.55 per hour for the entire space.

1.16 24-HOUR HVAC REQUIREMENT (APR 2011)

The Overlime Usage rate specified above shall not apply to any portion of the Premises that is required to have heating and cooling 24 hours per day. If 24 hour HVAC is required by the Government for any designated rooms or areas of the Premises, such services shall be provided by the Lessor at an annual rate of \$0.00 per ABOA sq. it. of the area receiving the 24 hour HVAC.
