hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease: To order tenant improvements which exceed the tenant improvement allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon full execution by the Government as follows:

1). This Lease Amendment (LA) No. 1 is your **Notice to Proceed (NTP)** to furnish and install Tenant Improvements as required and outlined in Lease No. GS-07B-17049. The total cost for the Tenant Improvement (TI) is **\$451,088.00** pursuant to attached Exhibit "A" and "B". Of the **\$451,088.00** only **\$159,004.30** has been amortized into the rent at 7.75% for 120 (One hundred twenty) months. The Government hereby orders the balance of **\$292,083.70 (\$451,088.00 - \$159,004.30 = \$292,083.70)**.

2). Upon completion, inspection and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of **\$292,083.70**, upon receipt of an original invoice after completion, inspection and acceptance of the space by the Contracting Officer.

Invoices shall be submitted to the Greater Southwest Finance Center (with copy to the Contracting Officer) electronically on the Finance website at www.finance.gsa.gov. Lessors who are unable to process the invoices electronically may mail the invoices to the following address:

All other terms and conditions of the lease shall remain in force and effect.
