THIS AGREEMENT, made and entered into this date by and between Bayou Verret Lands, LLC., whose address is 2709 Ridgelake Dr., Ste. 100 Metairie, LA 70002-6061 hereinafter called the Lessor and UNITED STATES OF AMERICA, hereafter call the Government

WHEREAS, the parties hereto desire to amend the above lease. The purpose of this Lease Amendment 4 (LA-4) is to provide alterations to the above named lease space and provide for payment to the Lessor.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution as follows:

1. The Lessor shall provide the alterations at 2424 Edenborn, Ste. 460, Metairie, LA 70001-6474 as specified in the Scope of Work, Exhibit A, in consideration of a one-time lump sum payment not to exceed \$723.60 as stated in the Lessor's Proposal, Exhibit B. Both Exhibits A and B are attached hereto and made a part hereof.
2. Lessor will maintain all alterations. Lessor hereby waives all rights to restoration pertaining to these alterations.
3. All work will be completed within 112 calendar days of Notice to Proceed and is effective on the date of completion of the preconstruction meeting. Work will be coordinated with Derek Duvic at (504) 289-7591.
4. Change orders must be approved by the Contracting Officer.
5. Full execution of this lease agreement will serve as the Government's **NOTICE TO PROCEED**.
6. Payment will be made upon completion of the work by the Lessor and acceptance by the Government.
