WHEREAS, the parties hereto desire to amend the above Lease to **issue notice to proceed for Tenant Improvements.**

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon execution by the Government, as follows:

This Supplemental Lease Agreement (SLA) formally and officially issues Notice to Proceed in the amount of \$253,982.62 for the Federal Bureau of Investigations' Tenant Improvements in accordance with the lessor's proposal dated 10/04/2010. The proposal is hereby incorporated into the lease by reference.



The total Tenant Improvement amount represents the following: (1) Tenant Improvement of \$253,982.62, to be paid as follows, \$85,774.45 amortized in the rent at an interest rate of 7.5% over ten (10) years and the balance of \$168,208.17 to be paid via a one-time lump sum payment. All lump sum payments shall be paid upon inspection and acceptance by the Government of the said alterations.

The lessor hereby waives restoration as a result of all improvements.

All other terms and conditions of the lease shall remain in force and effect.

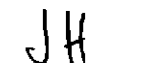
For an invoice to be considered proper, it must:

- ◆ Indicate the exact payment amount requested, and
- ◆ Specify the payee's name and address. The payee's name and address must EXACTLY match the Legal Business Name or DBA associated with it in Central Contractor Registration (CCR) for the DUNS included above.

Payment will be due within thirty (30) days after GSA's designated billing office receives a properly executed invoice or acceptance of the work by the Government, whichever is later.
