hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective $\frac{3}{1/98}$, as follows:

This Supplemental Lease Agreement is issued to establish the <u>new</u> rental rate and CPI adjustment effective <u>March 1</u>, 1998, for Silver Spring Metro III due to special vacant space credit for cleaning in the Fitness Center (8,299 sq. ft) and (7,452 sq. ft). It was agreed that Pioneer Building Services, Inc., cleaning contractor, for Fougler-Pratt, Lessor, would provide \$.96 per sq. ft. credit for the Fitness Center and \$.78 per sq. ft. credit for the Calculation of the reduction is computed as follows:

FITNESS CENTER:

 $\$.96 \times 8,299 \text{ sq. ft.} = \$ 7,967.04$

 $\$.78 \times 7,452 \text{ sq. ft.} = \$5,812.56$

TOTAL = \$13,779.60/yr. divided by 12 months = \$1,148.30/mo.

Old Annual Rent: \$11,838,890.02 New Annual Rent: \$11,825,110.42 Old Monthly Rent: \$ 986,574.17 New Monthly Rent: \$ 985,425.87

Current base for CPI adjustment: \$1,096,145.35 New base for CPI adjustment: \$1,082,365.75

All other terms and conditions of the lease shall remain in force and effect.
