This amount shall be paid out of the for pricing change listed above, so that the balance for supplies pricing change is \$3,343.00. 3. The cost of construction is further amended by Change Orders (CO) 7, 8 and 9. CO7 electrical work, CO8 - I /millwork in the reception area, and CO9 -/window treatments. The total amount due Lessor for these three change orders is \$29,465.95, which also includes for inspection fees. This amount shall be reduced by the remainder of the supplies pricing change (\$3,343.00) and the general conditions fee \$11,122.95. The total construction cost is \$1,051,368.95. , so that the balance due the Lessor is 4. Lessor shall provide all labor, material, supervision, equipment and permits to accomplish these changes. All work shall be performed in accordance with the attached "GENERAL CONDITIONS FOR LEASE ALTERATIONS", attached hereto and incorporated herein by reference as Attachment 1.
