- 3.) <u>Building Specific Amortized Capital</u>: the Lessor and the Government acknowledge that a lease amendment will be executed to reconcile the Building Specific Amortized Capital retroactively to the Rent Commencement Date and to confirm said rental adjustment is to include the amortization of the Building Specific Amortized Capital as referenced in Paragraph 1.03 of the Lease.

All other terms and conditions of the lease shall remain in force and effect.
