THIS AGREEMENT, made and entered into this date by and between
LGK Development LLC
whose address is 3200 Carbon Place
Boulder CO, 80301-6132

Herein after called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:
WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective as of the date of this Supplemental Agreement 1, as follows:

This Supplemental Lease Agreement (SLA) No. 1 is issued to document the agreed total amortized and unamortized tenant improvements pursuant to the Design Intent Drawings and Special Requirements, attached as part of this lease. Accordingly, Paragraph 27 is added to this lease as follows:

27. The total Tenant Improvement cost to produce the space pursuant to the Design Intent Drawings and Special Requirements, is \$939,071.30 including payments for TI overages. Of this amount \$35.77/usf or a total of \$860,375.81, will be amortized into rent payments over 120 months at 6.875%. The Government agrees to pay the Lessor a one time lump sum payment in the amount of \$78,695.49 for initial tenant improvement construction costs that will not be amortized in the monthly rental payments, but will be paid upon acceptance of the space.

The Special Requirements and government Design Intent Drawings will be an attachment to this SLA No. 1 showing the source from which the agreed tenant improvements were negotiated from.

Initial Tenant Improvement Overage \$78,695.49

The lessor waives any right to future payment for the initial construction costs except for the \$860,375.81 that will be amortized in monthly rent as stated in Paragraph 3 of this lease. Submit invoice only after the lease is activated after the Government accepts the space.

All other terms and conditions of the lease shall remain in force and effect.
