The total cost of the alterations is <u>\$2,280.00</u>. Upon completion of the work in a manner satisfactory to the Government, and after submission by the Lessor of a certified invoice, the Government agrees to pay the Lessor a lump-sum payment of exactly <u>\$2,280.00</u>.

Upon substantial completion and acceptance of said space, the Government shall issue a subsequent SLA reconciling all Tenant Improvement Costs to include changes, if any.
