WHEREAS, the parties hereto desire to amend the above Lease. Use of the GSA From 276, Supplemental Lease Agreement has been discontinued. All references in the lease to "GSA Form 276" or "Supplemental Lease Agreement" shall be now hereby construed to mean "Lease Amendment."

Lease Amendment No. 4 is being issued to make corrections and changes to Paragraph Nos, 3 and 13 and 21.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective March 31, 2012 as follows:

Paragraph No. 3 of SLA Number 2 is deleted in its entirety and replaced with the following:

The Government shall pay the Lessor annual rent of:

- April 1, 2012 March 31, 2017: \$57,500, or \$50.00/rentable square foot
- April 1, 2017 March 31, 2022: \$49,910, or \$43,40/rentable square foot

All rent shall be paid monthly, in arrears.

The Operating Cost portion of rent is subject to annual escalations as outlined in 4.3 Operating Costs of the Solicitation for Offers. Rent for a lesser period shall be prorated. Rent shall be paid via electronic funds transfer to the account the Lessor has identified in CCR/SAM.

Paragraph No. 21 is deleted in its entirety and replaced with the following:

A lump sum payment in the amount of \$15,035.95 will be made to the Lessor by GSA for tenant improvement costs for above standard Items requested by the tenant upon completion and acceptance of ballout by the Lesse Contracting Officer or Representative. This amount is determined to be mutually agreed upon by Advanced Chiropractic Center.
