SECTION 1 THE PREMISES, RENT, AND OTHER TERMS

1.01 THE PREMISES—SUCCEEDING (APR 2011)

Unless otherwise noted, the Government accepts the leesed premises and tenant improvements in their current existing condition on October 1, 2011, with the following exceptions further outlined more thoroughly in this solicitation. These exceptions include, but ere not limited to, security improvements, National Fire Protection Association (NFPA) requirements, ABAAS compliance, as well as compliance with all local codes end ordinances. The Lessor shall be responsible for continuing obligations for cleaning, janitorial, maintenance, repair, etc. as set in the below SFO paragraphs and attached General Clauses.

The Premises are described as follows:

<u>Laboratory and Related Space</u>: 5,400 rentable square feet (RSF), yielding 4,058 ANSI/BOMA Office Area (ABOA) square feet (sq. ft.) of office and related space (based upon a Common Area Factor of 1.330704781, located in the following Rooms of the Danforth Science Center: 1010-Main Lab, 1020-Office, 1021-Office, 1022-Office, 1023-Office, 1024-Vestibule, 1024B-Closet, 1025-Fiex Lab, 1026-Fiex Lab, as depicted on the floor plan(s) attached hereto as Exhibit _A_.

1.02 EXPRESS APPURTENANT RIGHTS (APR 2011)

The Government shall have the non-exclusive right to the use of Appurtenant Areas, and shall have the right to post Government Rules and Regulations within such areas. The Government will coordinate with the Lessor to ensure signage is consistent with the Lessor's standards. Appurtenant to the Premises and included with the Lease are rights to use the following:

- A. <u>Parking</u>: Five (5) parking spaces of which five (5) shall be surface parking spaces. In addition, the Lessor shall provide such additional parking spaces as required by the applicable code of the local government entity having jurisdiction over the Property.
- B. <u>Antennae, Satellite Dishes and Related Transmission Devices</u>: Space located on the roof of the Bullding sufficient in size for the installation and placement of the telecommunications aquipment as such may be described herein, together with the right to access the roof and use of, all building areas (e.g., chases, plenums) necessary for the use, operation and maintenance of such equipment at all times during the term of this Lease.

1.03 RENT AND OTHER CONSIDERATION—SUCCEEDING (APR 2011)

1.04 BROKER COMMISSION AND COMMISSION CREDIT (APR 2011)

Jones Lang LaSalle ("Broker") is the authorized real estate broker representing GSA in connection with this lease transaction. The total amount of the Commission is secured, and is earned upon lease execution, payable according to the Commission. Agreement signed between the two parties. Only the Commission, will be payable to Jones Lang LaSalle with the remaining which is the "Commission Credit", to be credited to the shell rental portion of the annual rental payments due and owing to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue until the credit has been fully recaptured in equal monthly installments over the shortest period practicable.

1.07 PERCENTAGE OF OCCUPANCY FOR TAX ADJUSTMENT, ESTABLISHMENT OF TAX BASE (APR 2011)
