WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

A total of 5,950 rentable (5,174 ANSI/BOMA office area) square feet of office and related space, with 36 on site parking spaces at no additional cost to the Government, to be constructed and located in the Brookwood Building at 130 Charter Street, City of Albemarle, County of Stanly, State of North Carolina, 28001.

- 2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on July 24, 2010 through July 23, 2020, subject to termination and renewal rights as may be hereinafter set forth.
- 3. The Government shall pay the Lessor annual rent for the entire term, monthly, in arroars, as follows: See Page 3. Paragraph 9.

Should Lessor make changes without approval, the Government will not be responsible for the cost of those changes and Lessor will not be reimbursed.

- In accordance with the SOLICITATION FOR OFFERS 7NC2120, Paragraph 4.3 (Operating Costs), base operating costs for services and utilities are established as \$31,000.00 (\$5.99 per BOMA office area square foot (rounded); \$5.21 per rentable square foot).
- In accordance with the SOLICITATION FOR OFFERS 7NC2120, Paragraph 4.4 (Adjustment for Vacant Premises), the rental rate reduction is established as \$5.99 per ANSI/BOMA square foot.
