WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective March 11, 2013, as follows:

1. The Government hereby accepts the Lessor's proposal to provide, install and maintain the tenant improvements as described in the attached exhibit to this SLA. Alterations shall be in full accordance with SFO 1NC2095, the Lease terms.

Total Cost: \$2,573.00

In accordance with paragraph 8 of the SF2 and SFO 0NC2036, the payment of the Tenant Improvement costs shall be broken down as follows:

Via lump sum as described in this agreement	\$2,573.00
Total:	\$ 2,573.00

2. The Government shall reimburse the Lessor in a lump sum payment in the amount of \$2,573.00 upon receipt of an original invoice after completion, inspection, and acceptance of the work by the Contracting Officer.
