THIS LEASE, made and entered into this date by and between GUNTER-LEWIS ENTERPRISES, LTD.

whose address is 1378 Anasazi Ct.

Las Cruces, NM 88007-1934

and whose interest in the property hereinafter described is that of owner, hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WITNESSETH: The parties hereto for the consideration hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

A total of 10,099 rentable square feet (RSF) of office and related space, which yields 7,402 ANSI/BOMA Office Area square feet (ABOA) of space located on the 1st Floor at 1701 Columbus Road in Deming, NM 88030-6724 (see Exhibit C - Legal Description) to be used for such purposes as determined by the General Services Administration. Included in the rent, at no additional cost to the Government, are 67 surface and reserved parking spaces.

- 2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning upon completion and acceptance of the work required by this lease and continuing for a period of fifteen (15) years, with a firm term of ten (10) years, subject to termination and renewal rights as may be hereinafter set forth. The actual lease term dates will be established by a subsequent Supplemental Lease Agreement.
- 3. For years 1 through 10, the Government shall pay the Lessor annual rent of \$285,261.94 (\$28.25/RSF \$38.42/ABOA) at the rate of \$23,771.83 per month in Arrears. The total annual rent consists of annual Shell rent of \$200,465.15 (\$19.85/RSF \$26.99/ABOA) at the rate of \$16,705.43 per month; annual Operating Costs of \$45,300.00 (\$4.49/RSF \$6.12/ABOA) plus annual CPI adjustments as stated in the Solicitation for Offer; and annual amortized Tenant Improvement Costs of \$39,496.79 (\$3.91/RSF \$5.31/ABOA).

For years 11 through 15, the Government shall pay the Lessor total annual rent of \$219,002.80 (\$21.69/RSF - \$29.49/ABOA) at the rate of \$18,250.23 per month paid in arrears. The total annual rent consists of annual Shell rent of \$173,702.80 (\$17.20/RSF - \$23.39/ABOA); Operating Costs of \$45,300.00 (\$4.49/RSF - \$6.12/ABOA) plus annual CPI adjustments as stated in the Solicitation For Offer. There are no annual Tenant Improvement Costs.

Rent for a lesser period shall be prorated. Rent shall be made payable to:

- 4. The Government may terminate this lease in whole or in part effective at any time after the tenth (10th) year of this lease by giving at least ninety (90) days' prior notice, in writing, to the Lessor. No rental shall accrue after the effective date of the termination. Said notice shall be computed commencing with the day after the date of the mailing.
- 5. This lease may be renewed at the option of the Government for the following rentals: Provided notice be given in writing to the Lessor at least days before the end of the original lease term or any renewal term; all other terms and conditions of this lease shall remain the same during any renewal term. Said notice shall be computed commencing with the day after the date of mailing.
- 6. The Lessor shall furnish to the Government, as part to the rental consideration, the following:
 - A. Those facilities, services, supplies, utilities, and maintenance in accordance with SFO 9NM2108 dated October 20, 2010.
 - B. Build out in accordance with standards set forth in SFO 9NM2108 dated October 20, 2010, as amended, and the Government's Design Intent Drawings. Government space plans shall be developed subsequent to award within 20 working days. All tenant alterations and improvements shall be completed by the date identified under Paragraph 9 of this SF-2
 - C. The Lessor hereby waives restoration of the leased premises.

- D. Deviations to the approved design intent drawings will not be permitted unless prior written authorization is obtained from the GSA Contracting Officer.
- E. Adequate space for telecommunications antennae and transmission devises in accordance with Paragraph 8.13 entitled, "Telecommunications: Local Exchange Access." of the SFO.

8. The following changes were made in this lease prior to its execution:

Paragraph 5 is omitted and has been struck through. Paragraphs nine (9) through nineteen (19) are added.

9. Budget and Price Proposals/Construction Schedule:

Pursuant to Paragraph 5.10, of the Solicitation of Offer "Construction Schedule and Acceptance of Tenant Improvements", the Lessor shall have 185 working days from the receipt of the Government Approved Design Intent Drawings to complete the build-out of the entire leased premise and have the space available for inspection and acceptance by the Government. All items specified in Lease Agreement and as delineated on the Government Approved Design Intent Drawings shall be provided by the Lessor.

10. Percentage of Occupancy:

The lease is subject to Real Estate Tax reimbursement as provided for in the Paragraph Tax Adjustment of the SFO. For tax adjustments, the percentage of occupancy is established at 100%. The base year tax statement will be submitted within 60 calendar days after Lessor's payment of taxes to establish the base tax year. If the statement is for multiple parcels or buildings, the value of each property shall be defined.

11. Operating Cost:

In accordance with the SFO paragraph entitled "Operating Costs," the escalation base is established as \$4.49/RSF or \$45,300.00 (10,099 rsf X \$4.49).

12. Common Area Factor:

In accordance with the SFO paragraph entitled "Common Area Factor," the common area factor is established as 1.36 (10,099 RSF/7,402 ABOA).

13. Adjustment for Vacant Premise:

In accordance with the SFO paragraph entitled "Adjustment for Vacant Premises," the adjustment shall be a reduction of \$6.12/ANSI-BOMA Office Area for vacant space.

14. Overtime HVAC Usage:

In accordance with the SFO Paragraph entitled Overtime Usage, the rate for Overtime Heating and Cooling is established at \$10.00 per hour for the entire Government leased premise. The Lessor shall not charge the Government for Overtime Heating and Cooling if the building is open and the Heating and Cooling is operating for all other tenants beyond the Normal Hours stipulated in this agreement. The Overtime Heating and Cooling Usage rate shall not apply to any portion of the Premises that is required to have heating and cooling 24 hours per day as specified by the lease agreement.

15. <u>Central Contractor Registration (CCR)/ ACH Form:</u> Per the Debt Collection Improvement Act, effective July 27, 1996, Electronic Funds Transfer (EFT) (See exhibit D) shall be required on all existing and new lease/contracts that became effective no later than January 1, 1998. An enrollment form is attached to be completed and returned with this contract.

In accordance with the SFO paragraph entitled "Central Contractor Registration," the Lessor shall register by the time of the full execution of this Lease Agreement.
