
NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective ____January 20, 2012 , as follows:

- I. Supplemental Lease Agreement (SLA) No. 008 is issued to document the firm fixed price agreement of several change order proposals where the Government issued a Notice to Proceed (NTP) in separate correspondence. The firm fixed price agreement includes, but not limited to, the necessary labor, materials, equipment, subcontracts, supervision, design fees and administration costs.
- II. The parties agree the total amount of the change order proposals in this SLA will be funded from the consruction cost credit that is available to the Government. Per SLA No. 5 that credit is \$507,424.65. With the off set of \$243,581,49, described below, the revised construction cost credit available to the Government is \$ 263,843.16.

The Lessor, by executing this SLA, represents and certifies to the Government that it has sought and received the Lender's prior approval and consent to this document, as may be required by the agreements by and between the Lessor and its Lender. Lessor acknowledges to the Government that it is Lessor's sole responsibility to assure compliance with any and all requirements for the Lender's prior review of, consent to, and approval of this SLA. All other terms and conditions of the Lease shall remain in force and effect.
