WHEREAS, the parties hereto desire to amend the above Lease to issue a Notice to Proceed; and order Tenant Improvements (TI) which exceed the TI allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended as follows:

- I. The Government has reviewed the Lessor's TI cost proposal and determined that the proposal is fair and reasonable. This SLA serves as the Lessor's Notice to Proceed for the construction of TIs in the amount of \$261,952.14. This amount includes all costs for labor, material, fees, overhead, profit, and any other costs required to complete the work.
- II. The total cost for Tenant Improvements in the amount of \$261,952.14 exceeds the tenant improvement allowance of \$204,247.68, which is stated in the lease and amortized into the rental rate. The costs for TIs over the TI allowance in the amount of \$57,704.46 will be paid via lump sum upon completion, inspection, and acceptance of the space; and upon receipt of an original invoice by the Contracting Officer.
