The total of these 2 submitted invoices = \$2,438,074.07 (TTI Costs) + \$304,496.98 (RWA Costs) = \$2,742,571.05 Total Costs

Lessor has provided a reconciliation statement of actual costs for the Tenant Improvements and RWA work.

In summary: \$2,842,174.97(available funds) less \$2,742,571.05 (Invoices = Funds in the amount of \$99,603.92 are no longer Needed for this project as Lessor has completed all invoicing.
