Upon completion, inspection, and acceptance of the tenant improvements by the GSA Contracting Officer, the Government will reimburse the Lessor for the total cost listed above. Reimbursement for all items will occur within 30 days of the Government's receipt of the Lessor's itemized invoice(s).
