- 1.) The Lessor shall provide all the materials, labor, and services required to provide for the completion of the Tenant Improvements as depicted and according to the Construction Drawings created by Stephen Baxter, Architect, dated April 28, 2011. Drawing list is attached as Exhibit 1. In addition, Lessor shall provide all the materials, labor, and services required to provide for the completion of the voice and data cabling as depicted and according to the Construction Drawings created by SMITHGROUP JJR, dated July 26, 2011. Drawing list is attached as Exhibit 2
- 2.) Upon full execution and delivery of this Supplemental Lease Agreement (SLA) the Lessor can consider this as a Notice to Proceed with the construction of the Tenant Improvements and voice and data cabling (the "Work"). The anticipated date of the completion of the Work and acceptance by the Government is on or before April 17, 2012.
- 3.) The Government shall pay the Lessor for the total cost of the Work as follows:

The total cost of the Work has been estimated to be \$303,754.69. The total Work cost includes all the Lessor's fees for general and administrative costs, profit and any and all other fees associated with the completion of the Work by the anticipated date of completion. The total cost of the Work is depicted on Exhibit 3, attached.

Any changes of the Construction Drawings, which result in a financial change to the lease agreement, of any type, must be approved, in writing, by the GSA Contracting Officer.

A portion of the total Work costs, \$221,616.00, shall be amortized according to a ten year schedule at an interest rate of six and a half percent (6.5%) paid monthly in arrears. The annual cost of the amortized portion of the Work cost is \$30,196.86 paid monthly in arrears in the amount of \$2,516.40.

The remaining balance of the total cost of the Work is \$82,138.69 [\$303,754.69 - \$221,616.00] and it shall be paid by a lump-sum payment upon the substantial completion and acceptance by the Government of the Work.

To submit for payment of the lump-sum-payment, the Lessor agrees that the invoice shall be printed on the same letterhead as the named on this lease, shall include the Lease number, building address, and a price and quantity of the items delivered. The invoice shall reference the number PS0023278 and shall be sent electronically to the GSA Finance Website at http://www.finance.gsa.gov/defaultexternal.asp . Instructions for invoice submission are included on the website. Additional assistance is available from the Finance Customer Service line at 817-978-2408.
