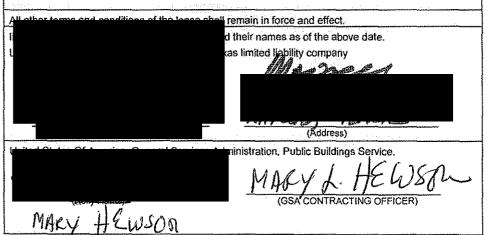

Paragraph 2 of the lease is hereby deleted and replaced with the following: "TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on November 24, 2010 through November 23, 2020, subject to termination and renewal rights as may be hereinafter set forth."

- 2. This serves as the official approval for the Electric Strike Change Order #3 and issue Notice to Proceed in the amount not to exceed \$1,120.00. This amount shall include all materials, labor, and overhead, as described further in Lessor's change order proposal, to complete the work to the Government's satisfaction. Upon completion, inspection, and approval of the work by the Government, the Lessor shall be paid via a one-time lump sum payment in the amount of \$1,120.00 for this change. The proposal for this change is hereby attached and made a part of the lease. The Electric Strike change (Change Order #3) consists of the following:
 - Provide (1) HES 8000 Series Electric Strike
 - Provide and install conductors from low voltage panel to door #101
 - Install junction box/receptacle above ceiling at door #101
 - Install (1) 20 AMP (1) pole breaker in low voltage panel for new circuit
 - includes remobilization and installation.

All other terms and conditions of this lease shall remain in full force and effect.

5. Paragraph 10 of the SF2 is hereby deleted and replaced with the following:

"In accordance with SFO paragraph 2.7, Broker Commission and Commission Credit, CB Richard Ellis, Inc. ("CBRE") is the authorized real estate broker representing GSA in connection with this lease transaction. The Lessor and CBRE have agreed to a cooperating lease commission of the firm term value of this lease ("Commission"). The total amount of the Commission is execution and payable (i) one-half (1/2) when the Lease is awarded and (ii) one-half (1/2) upon the earlier of Tenant's occupancy of the premises leased pursuant to the Lease or the commencement date of the Lease.
