

U.S. GOVERNMENT LEASE FOR REAL PROPERTY

THIS LEASE, made and entered into this date by and between **NNN Lavaca Plaza REO, L.P.**

whose address is: 16055 Space Center Boulevard, Suite 235
Houston, TX 77062-6212

and whose interest in the property hereinafter described is that of **OWNER**

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

- The Lessor hereby leases to the Government the following described premises:

A total of 4,419 rentable square feet (RSF) of office and related space, which yields 3,764 ANSI/BOMA Office Area square feet (USF) of space on the ninth floor of the building located in Lavaca Plaza, at 504 Lavaca Street, Austin, TX 78701-2856 to be used for such purposes as determined by the General Services Administration. Included in the rent at no additional cost to the Government are two (2) covered, reserved parking spaces for the exclusive use of Government employees and patrons.

- TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on the date the Government accepts the premises as substantially complete and continuing for fifteen (15) years, subject to termination and renewal rights as may be hereinafter set forth. Actual lease term dates will be established by Supplemental Lease Agreement.

- The Government shall pay the Lessor monthly in arrears in accordance with the following table:

- The Government may terminate this lease in whole or in part at any time after the tenth (10th) year by giving at least one hundred and twenty (120) days' notice in writing to the Lessor and no rental shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing.

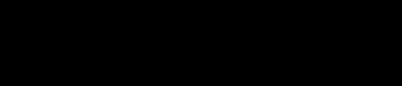

5. Paragraph 5 is intentionally deleted.
6. The Lessor shall furnish to the Government, as part to the rental consideration, the following:
 - A. Two (2) reserved parking spaces.
 - B. All labor, materials, equipment, design, professional fees, permit fees, inspection fees, utilities, construction drawings (including, without limitation, plans and specifications), construction costs and services and all other similar costs and expenses associated with making the space, common areas, and related facilities ready for occupancy in accordance with the requirements of this lease and the Government's final construction drawings. Rent is subject to adjustment in accordance with Paragraph 3.3, "Tenant Improvement Rental Adjustment" of the SFO. All cost associated with services, utilities, maintenance, repair, replacement, inspections, improvements and other requirements as required by the Solicitation For Offers No. 6TX170 and its attachments.
 - C. Deviations to the Government's design intent drawings will not be permitted unless prior written authorization is obtained from the GSA Contracting Officer.

8. The following changes were made to this lease prior to its execution and made a part hereof:
9. In accordance with SFO paragraph 3.3, *Tenant Improvements Rental Adjustment*, Tenant Improvements in the total amount of \$128,307.38 (3,764 USF x \$ 34.088040) shall be amortized through the rent over the firm term of the Lease (120 months) at the rate of five percent (5%). The total annual cost of Tenant Improvements for the amortization period shall be \$16,330.79.
10. In accordance with the SFO paragraph entitled Percentage of Occupancy, the percentage of Government occupancy is established as 3.72%.
11. In accordance with SFO paragraph 4.3, *Operating Costs Base*, the escalation base is established as \$30,049.20 per annum.
12. In accordance with SFO paragraph 4.1, *Measurement of Space*, the common area factor is established as 1.174 (4,419 RSF / 3,764 USF).

The total ANSI/BOMA square foot area referred to in Paragraph 1 of the SF-2 herein is subject to an adjustment with the actual number of ANSI/BOMA square feet delivered to be determined by mutual field measurements in accordance with provision of Paragraph 4.1 in the SFO. However it is mutually agreed that the total ANSI/BOMA office area square feet must meet the minimum requirement of 3,756 ANSI/BOMA office area square feet as stated in Paragraph 1.1 of the SFO.
13. In accordance with SFO paragraph 4.4, *Adjustment for Vacant Premises*, the adjustment is established as \$2.00/USF for vacant space (rental reduction).
14. In accordance with SFO Paragraph 4.6, *Overtime Usage*, the rate for overtime usage is established as \$45.00 per hour beyond the normal hours of operation of 7:00AM to 5:00PM. Areas that require 24/7 will be separately metered and reimbursed.
15. Security costs in the total amount of \$25,700.00 shall be amortized through the rent for 120 months at the rate of 5.00%.
16. The Lessor hereby forever and unconditionally waives any right to make a claim against the Government for restoration arising from alteration or removal of any alteration by the Government during the term of this lease or any extensions. Alterations completed by either the Government or Lessor including initial build out of the

lease space and/or any subsequent modifications required during the lease period. At the Government's sole discretion alterations will remain in the leased space after termination of the Lease contract and will become property of the Lessor.

17. All questions pertaining to this lease shall be referred to the Contracting Officer of the General Services Administration (GSA) or his/her designee. The Government occupant is not authorized to administer this lease, and GSA assumes no responsibility for any cost incurred by Lessor except as provided by the terms of this lease or any other cost authorized in writing by the GSA Contracting Officer. The Lessor will not be reimbursed for any services not provided for in this Lease, including but not limited to; repairs, changes in scope of work, alterations, and overtime services without the written authorization of a Contracting Officer. Additionally, rental will not be paid for occupancy in whole or in part except for the term specified herein.
18. Unauthorized Improvements: All questions pertaining to this lease agreement shall be referred in writing to the General Services Administration Contracting Officer. This contract is between GSA and NNN Lavaca Plaza REO, L.P. GSA assumes no financial responsibility for any cost incurred by the Lessor except as provided by the term of the lease agreement or authorized in writing by the GSA Contracting Officer. **If Lessor delivers space with improvements not authorized or requested in writing by the GSA Contracting Officer, then Lessor shall not be entitled to compensation if the improvements remain in place after the Government's acceptance of the space.**
19. Within thirty (30) days of lease occupancy, the Lessor shall provide the tenant agency representative (with a copy forwarded to the GSA Government Representative), on site, a copy of the name and phone number of maintenance personnel in order that any cleaning, maintenance, janitorial, etc. problems can be taken care of immediately.
20. [REDACTED] shall be provided by the Lessor in accordance with SFO paragraph 10.22, [REDACTED]. The cost is included in building-specific security.
21. In accordance with SFO paragraph 2.6, *Broker Commission and Commission Credit*, CB Richard Ellis, Inc. ("CBRE") is the authorized real estate broker representing GSA in connection with this lease transaction. The Lessor and CBRE have agreed to a cooperating lease commission of [REDACTED] of the firm term value of this lease ("Commission"). The total amount of the Commission is [REDACTED]. This Commission is earned upon lease execution and payable (i) one-half (1/2) when the Lease is awarded and (ii) one-half (1/2) upon the earlier of Tenant's occupancy of the premises leased pursuant to the Lease or the commencement date of the Lease. Due to the Commission Credit described in Paragraph 2.4, only [REDACTED], which is [REDACTED] of the Commission, will be payable to CBRE when the Lease is awarded. The remaining [REDACTED], which is [REDACTED] of the Commission ("Commission Credit"), shall be credited to the shell rental portion of the annual rental payments due and owing shall be reduced to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first full month of the rental payments and continue until the credit has been fully recaptured.
- First month's rental payment of \$11,826.65 minus the prorated commission credit of [REDACTED] equals [REDACTED] (adjusted first month's rent).
- Second month's rental payment of \$11,826.65 minus the prorated commission credit of [REDACTED] equals [REDACTED] (adjusted second month's rent).
- Third month's rental payment of \$11,826.65 minus the prorated commission credit of [REDACTED] equals [REDACTED] (adjusted third month's rent).
- Fourth Month's Rental Payment shall commence in full.
- *subject to adjustment upon determination of actual TI expenditure.
22. Pursuant to paragraph 2 of the SF-2, the Government and Lessor mutually agree to hold a Project Kick-off meeting 5 working days from the lease award date. From the date of the Project Kick-off meeting, the Lessor shall prepare and provide to the Government design intent drawings within 15 working days from award.
