## SECTION 1 THE PREMISES, RENT. AND OTHER TERMS

## 1.01 THE PREMISES (SUCCEEDING) (JUN 2012)

Unless otherwise noted, the Government accepts the Premises and tenant improvements in their existing condition, except where specifications or standards are contained elsewhere in this Lease. These standards include security improvements, Fire Protection and Life Safety requirements, ABAAS compliance, as well as compliance with all local codes and ordinances. Such acceptance by the Government of existing Premises shall not relieve Lessor of continuing obligations for cleaning, janitorial, maintenance, repair, etc. as set forth in the Lease paragraphs and attached General Clauses

The Premises are described as follows:

- A. Office and Related Space: 11,842 rentable square feet (RSF), yielding 9,497 ANSI/BOMA Office Area (ABOA) square feet (SF) of office and related Space located on the 30<sup>th</sup> floor(s) and known as Suite(s) 3050 and 3030, of the Building, as depicted on the floor plan(s) attached hereto as Exhibit B.
- B. <u>Common Area Factor</u>: The Common Area Factor (CAF) is established as **1.24** percent. This factor, which represents the conversion from ABOA to rentable square feet, rounded to the nearest whole percentage, shall be used for purposes of rental adjustments in accordance with the Payment Clause of the General Clauses.

# 1.02 EXPRESS APPURTENANT RIGHTS (JUN 2012)

The Government shall have the non-exclusive right to the use of Appurtenant Areas, and shall have the right to post Rules and Regulations Governing Conduct on Federal Property, Title 41 CFR, Part 102-74, Subpart C within such areas. The Government will coordinate with Lessor to ensure signage is consistent with Lessor's standards. Appurtenant to the Premises and included in the Lease are rights to use the following:

A. <u>Parking</u>: As part of the annual rent, the Lessor will provide sixteen (16) unreserved spaces for the use of the Government, all sixteen (16) shall be structured/inside parking spaces, and zero (0) shall be surface/outside parking spaces. In addition, Lessor shall provide such additional parking spaces as required by the applicable code of the local government entity having jurisdiction over the Property.

## 1.03 RENT AND OTHER CONSIDERATIONS (SEP 2012)

A. The Government shall pay the Lessor annual rent, payable in monthly installments in arrears, at the following rates:

The effective date of the termination shall be the day following the expiration of the required notice period or the termination date set forth in the notice, whichever is later. No rental shall accrue after the effective date of termination. If the Government elects to terminate a portion of the Lease, the configuration and location of the space terminated must be reasonable acceptable to the Lessor for the purposes of future leasing and the Government shall be solely responsible for all costs associated with demising the space.
