WHEREAS, the parties hereto desire to amend the above Lease to 1) to provide Notice to Proceed for the Scope of Work, 2) to modify Section 7.03, and 3) to provide payment for the Scope of Work.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution by the Government as follows:

1. Upon full execution and delivery of this Lease Amendment No. 2 the Lessor shall consider this a Notice to Proceed (NTP) with the Scope of Work described in Exhibit A-LA#2, which is hereby incorporated into the Lease.
2. Section 7.03 OTHER REQUIREMENTS is hereby deleted in its entirety and replaced with the following:
 "Pursuant to Section 5.07 PAINTING-TI (SEP 2013) and Section 5.08 FLOOR COVERINGS AND PERIMETERS (SEP 2013), of said Lease, the Lessor shall complete the Tenant Improvements within 150 working days following Lease award."
3. Upon substantial completion, inspection, and acceptance of the alterations by the Contracting Officer, the Government shall reimburse the Lessor in a lump sum payment not to exceed [REDACTED].

To submit for payment, the Lessor agrees that the invoice shall be printed on the same letterhead as the named on this Lease, shall include the Lease number, building address, and a price and quantity of the items delivered. The invoice shall reference the number PS0030544 and shall be sent electronically to the GSA Finance website at <http://www.finance.gsa.gov/defaultexternal.asp>.
