WHEREAS, the parties hereto desire to amend the above Lease to incorporate **Notice to Proceed on the change order described below.**

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective **July 15, 2010** as follows:

- A. The lessor shall furnish, install and maintain all labor, material, tools, equipment, services and associated work to perform the scope of work in the change order outlined in the attached proposal.
- B. The total negotiated cost of this change order, as outlined in the attached proposals, is **\$8,069.00**. The change order is comprised of the following changes:

- [REDACTED] to correct door #1 in accordance with the attached proposal dated June 16, 2010
- [REDACTED] to correct 11 other doors in accordance with the attached proposal dated June 14, 2010
- [REDACTED] to prime and paint new doors in accordance with the attached proposal from Kron Painting dated June 14, 2010
- [REDACTED] to furnish and install a closer and drop plate on exterior gate in accordance with the attached proposal from Professional Lock dated June 16, 2010.
- [REDACTED] to furnish and install required electrical changes, in accordance with attached CMI proposal dated July 9, 2010.
