THIS AGREEMENT, made and entered into this date by and between Northview Corporate Center, LLC,

whose address is: 20700 44th Ave W
Lynnwood, WA 98036-7742

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above lease to order change orders to tenant improvements, which exceed the tenant improvement allowance.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective June 15, 2011, as follows:

On June 7, 2011, the Government issued a Notice To Proceed (NTP) for construction of TIs on expansion space of 11,663 RSF at 20700 44th Ave. W. Lynnwood, WA 98036. This NTP was issued in the total amount of \$584,254.00. This amount exceeded the TIA (Tenant Improvement Allowance) of \$471,603.00, by a total of \$112,651.00. Subsequently, the Lessor submitted change orders #1, #2, & #3, as attached hereto as Exhibit #1. These change orders total \$12,964.17, and have been reviewed by the Government and determined to be fair and reasonable.

Therefore, this SLA orders tenant improvements in the amount of \$12,964.17. This amount shall be paid to the Lessor via a one-time lump sum payment. This payment shall occur upon completion, inspection, and acceptance of the work by the Government and receipt of a complete invoice for this work, as described below. Total cost of the project is now calculated as not to exceed \$597,218.17.

Only the GSA Contracting Officer has the authority to obligate Government funds for any work, request or demand under the terms and conditions of the contract. While there may be discussions regarding potential changes, you are required to obtain approval from the GSA Contracting Officer through a signature or written affirmation prior to proceeding, regardless of cost.

The Lessor is to maintain a budget log and tracking of all expenditures against the agreed upon amount above and provide this at the request of the government. The Lessor is also required to track all change orders and seek approval of all change orders from the GSA Contracting Officer prior to the commencement of work. Change orders are to be reflected as part of the budget tracking, regardless of cost.
