THIS AGREEMENT, made and entered into this date by and between The Tower, LLC

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease to add 81 rentable square feet for a telecommunications closet (Bock B), to establish completion of tenant improvements, and to establish Beneficial Occupancy.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective April 9, 2012. Therefore, paragraphs 1, 2, 3, 4, 5, and 15 of the Lease are hereby deleted and replaced in their entirety as follows and paragraph 20 has been added:

1. The Lessor hereby leases to the Government the following described premises:

A total of 13,384 rentable square feet (RSF) of office and related space, which yields 12,732 ANSI/BOMA Office Area square feet (USF) of space at the Tower Building, 402 E. Yakima Avenue, 2<sup>nd</sup> and 3<sup>rd</sup> Floors, Yakima, Washington to be used for such purposes as determined by the General Services Administration. Space is comprised of a total of 13,303 rentable square feet (RSF) of office and related space, which yields 12,651 ANSI/BOMA Office Area square feet (USF) on floors 2 and 3 (Block A) and an 81 rentable square feet (RSF) telecommunication closet (Block B) located in the basement. The Block B space is not subject to operating cost or real estate tax escalations and does not affect square footages and percentages in paragraphs 9, 10, 11, and 12. In addition, Lessor leases to the Government seven (7) structured and five (5) surface parking spaces at no additional cost to the Government.

- 2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on April 9, 2012, through October 8, 2019, subject to termination and renewal rights as may be hereinafter set forth.
- 3. The Government shall pay the Lessor Annual Rent of \$356,177.45 at the rate of \$29,681.45 per month in arrears.


