WHEREAS, the parties hereto desire to amend the above Lease to order Tenant Improvements (TIs) which exceed the Tenant Improvement Allowance (TIA).

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective April 1, 2013, as follows:

Paragraph 22 is hereby added to the Lease: 22. Notice to Proceed for TI costs over the Tenant Improvement Allowance and Lump Sum Payment

A. The Government has reviewed the Lessor's TI cost proposal and determined that the proposal is fair and reasonable. This Lease Amendment serves as the Lessor's Notice to Proceed for the construction of TIs in the amount of \$941,809.62. Said amount includes all costs for labor, materials, fees, overhead, profit and any other costs required to complete the work.

The total cost for Tenant Improvements in the amount of \$941,809.62 exceeds the TIA of \$479,890.40, which is stated in the Lease and amortized into the rental rate. The costs for TIs over the TIA in the amount of \$461,919.22 will be paid via lump sum upon completion, inspection, and acceptance of the space; and upon receipt of an original invoice.
