WHEREAS, the parties hereto desire to amend the above Lease to approve pricing for Tenant Improvements.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective January 23, 2013, as follows:

1. In separate correspondence dated August 9, 2012, the Government issued final Notice to Proceed in the amount of **\$513,953.32** which includes \$416,839.04 amortized over the firm term and \$97,114.28, which exceeds the Tenant Improvement Allowance in the lease and is to be paid lump sum.

This LA#6 is issued to approve:

This amount includes all materials, labor and overhead and the Lessor is to complete the work to the Government's satisfaction.
