WHEREAS, the Government and the Lessor have previously agreed to tenant improvements for this lease and;

WHEREAS, the Government desires to make additions/changes through change orders;

WHEREAS, SLA No. 9 provides approval and the Notice-to-Proceed for Change Order #12, Change Order #13, Change Order #14, and Change Order #15;

WHEREAS, the Government wants to approve Change Order #12, Change Order #13, Change Order #14, and Change Order #15, in the amount of [REDACTED] to be paid in a lumpsum payment to the Lessor upon completion of the work and acceptance of space by the Government.

THEREFORE, the parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended effective on July 24, 2012 as follows:

Supplemental Lease Agreement (SLA) No. 9 to lease GS-05B-18366, is hereby issued to provide NOTICE TO PROCEED for Change Order #12, #13, #14 and #15 as follows:

Change Order #12 – electrical MDF room changes in the amount of [REDACTED] as shown in Exhibit A attached to this SLA No 9. Exhibit A is the Lessor's proposal for electrical MDF room changes for Change Order #12.

Change Order #13 – furnish and install 2 sets of VGA cables and install an exhaust fan in room 251 in the amount of [REDACTED] as shown in Exhibit B attached to this SLA No 9. Exhibit B is the Lessor's proposal to furnish and install 2 sets of VGA cables and install an exhaust fan in room 251 for Change Order #13.

Change Order #14 – relocate card readers, install peephole in door 203B and install 20 corner wall guards in the amount of [REDACTED] as shown in Exhibit C attached to this SLA No 9. Exhibit C is the Lessor's proposal to relocate card readers, install peephole in door 203B and install 20 corner wall guards for Change Order #14.
