- 2. The Lessor and the Government agree that the Tenant Improvement lump sum payment amount will be increased by \$5,300.00, changing the lump sum payment from \$73,705.00 to \$79,005.00, to be paid in a lump sum payment by the Government upon our inspection and acceptance of the work. No additional funding will be authorized under this Lease Amendment. The Lessor shall provide proper invoice for this amount only per the invoice instruction contained in this Lease Amendment (LA) and by referencing: PS0031545.
- 3. The occupying tenant agency does not have the contractual authority to enter into any agreements with the Lessor or the Lessor's representatives for improvements, changes or modifications of this lease agreement unless, approved by a GSA
