- Therefore, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$111,346.21 upon receipt of
  an original invoice after completion, inspection, and acceptance of the work by the Lease Contracting Officer or Lease
  Contracting Officer Representative.
