NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective October 2, 2014, as follows:

- A. With regard to General Clauses paragraph 1, SUBLETTING AND ASSIGNMENT, the Government agrees that the Lessor will not be considered unreasonable if consent for any Assignment is denied by the Lessor if the proposed Assignee does not have a Standard & Poor's credit rating of AA+ or higher. The Government's right to Sublet the Premises remains unaffected by this action.
- **B.** With regard to Lease paragraph 2.07, REAL ESTATE TAX ADJUSTMENT, the Lessor and the Government agree that no tax Adjustment will be made (increase or decrease) until the initial (100%) Tax Abatement period ends on August 25, 2024, as authorized by the City of Grandview ordinance dated August 26, 2014, which is attached and made a part hereof. Beginning on August 26, 2024, the Real Estate Tax Base for Adjustments shall be \$115,000.00 until the partial (50%) Tax Abatement period ends on August 7, 2032. Beginning on August 8, 2032, the Real Estate Tax Base for Adjustments shall be \$230,000.00 for the remaining term of the Lease.
