WHEREAS, the parties hereto desire to amend the above Lease to 1) provide for a Notice to Proceed for Change Order (C/O) #4; and 2) to order tenant improvements which exceed the tenant improvement allowance; and 3) waive restoration.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon execution by the Government, as follows:

1. This Lease Amendment is your Notice to Proceed with the following agency requested change order:

2. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of [REDACTED], upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.
