THIS AGREEMENT, made and entered into this date by and between Burnett Plaza LP, formerly known as Behringer Harvard Burnett Plaza LP.

hereinafter called the Lessor and UNITED STATES OF AMERICA, hereinafter called the Government  
WHEREAS, the parties hereto desire to amend the above lease.

NOW THEREFORE, These parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective June 30, 2015 as follows:

Burnett Plaza LP, formerly known as Behringer Harvard Burnett Plaza LP., a Texas Limited Partnership duly organized and existing under the laws of the State of Texas and the United States of America (Government), enter into this agreement as of June 30, 2015.

- (a) The parties agree to the following facts:
- (1) The Government, represented by various Contracting Officers of the General Services Administration, has entered into a lease for real property Lease No. GS-07B-14678 with Behringer Harvard Burnett Plaza LP. The term Lease as used in this Agreement refers to the original Lease and all subsequent modifications made by the Government and the Lessor before the effective date of this Agreement (whether or not performance and payment have been completed and releases executed if the Government or the Lessor has any remaining rights, duties, or obligations under the Lease).
  - (2) Behringer Harvard Burnett Plaza LP., by virtue of an amendment to its certificate of incorporation dated June 30, 2015, has changed its name to Burnett Plaza LP.
  - (3) This amendment accomplishes a change of name for the Lessor only and all rights and obligations of the Government and of the Landlord under the Lease are unaffected by this change.
  - (4) Documentary evidence of this change of name has been filed with the Government as shown in the attached "EXHIBIT A" along with the Certificate of Secretary attached as "EXHIBIT A-1" and incorporated into this Agreement by reference.

(b) In consideration of these facts, the parties agree that –

- (1) The Lease covered by this Agreement is amended by substituting Burnett Plaza LP for Behringer Harvard Burnett Plaza LP., for Burnett Plaza LP, wherever it appears in the contracts; and
- (2) Each party has executed this Agreement as of the day and year first written above.
