WHEREAS, the parties hereto desire to amend the above Lease to provide Notice To Proceed for one change order.

NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective March 11, 2011, by adding Paragraph 30 as follows:

30. On February 2, 2011 a Notice to Proceed was issued for Tenant Improvements in the amount not to exceed \$106,071.00. Of this amount, \$69,001.00 shall be amortized in the rent and the remaining \$37,070.00 shall be paid via lump sum payment. This SLA No. 2 approves Change Order1 per the Change Order dated 03/8/2011 in the amount not to exceed \$824.36 and issues the Notice to Proceed for construction of the Change Order. This amount shall include all materials, labor, and overhead, as described further in the Change Order Log, and the lessor is to complete the work to the Government's satisfaction. Upon completion, inspection, and acceptance of the work by the Government, the Lessor shall be paid via a one-time lump sum payment in the amount not to exceed \$37,894.36. The change order is hereby attached and added to the lease.

The Government, if approved by the Contracting Officer in writing, may adjust the amortized and lump sum amounts to reflect any additional Tenant improvement costs or credits during the course of the project. Any Tenant Improvement amount above the original tenant allowance will be paid pursuant to Paragraph 3.3 of the SFO."
